

Skills Certificates

The six courses are composed of 15 on-demand webinars which are supported by live online interactive lectures and a variety of online readings.

Skills Certificate in Digital and Technology

As more and more aspects of business become digital, the course explains the core features of digitalisation and the implications for business, particularly the impact on financial services, risk, regulation and customer expectations. The course focuses on the key challenges and opportunities that digital technology present for customers and business as they adapt to new ways of working.

Skills Certificate in Data

Increasingly the ability to use and understand data is a core competence for many roles in financial services, including fintech roles, compliance roles and risk management roles. This course outlines why data is a key asset in organisations and explains the core concepts in data analysis and interpretation.

Skills Certificate in Customer Advice and Service

The aim of this course is to increase competence and confidence in delivering excellent customer advice and service. It focuses on the core competencies required to consistently offer good service while ensuring that consumers' financial needs are met in a compliant and ethical manner.

Skills Certificate in Introduction to Funds Industry

This course aims to provide you with the fundamentals of investment funds, covering key aspects such as the types of investment funds, regulatory classifications, service providers and risks involved in the operation and servicing of funds. It covers themes and topics designed to deepen your learning, draw on your prior learning and enhance your career and professional prospects.

Skills Certificate in Risk Management in Financial Services

This course introduces the key relevant and emerging risks in the financial services industry, particularly in the area of risk management. The emphasis is on providing participants with the knowledge and practical skills to apply in their day-to-day roles.

Skills Certificate in Compliance

This course introduces participants to the role of compliance in the international financial services industry. It describes the regulatory environment in which financial services firms operate. It introduces participants to governance and compliance frameworks, and includes an introduction to how some aspects of compliance are managed such as data protection, Anti Money Laundering and AML activities.


